## Gas Contractor's Licencing Requirements

According to ***The Gas Licensing Act*** the following are requirements for a gas contractor's licence in the province of Saskatchewan.

1. At least one gas fitter, with the same class of licence (domestic or general) holding a valid Saskatchewan gas fitter licence. A gas fitter's licence shall not be used to entitle more than one person to either a contractor's licence or an employer's licence.
2. All gas contractors are required to furnish a guarantee bond in the penal sum of \$5,000 to Saskatchewan Ministry of Corrections, Public Safety and Policing. (Such a bond is available from any insurance company licenced in Saskatchewan.)
3. If the applicant is using a trading / business name, this name must appear on the contractor's bond. (e.g. John Smith O/A John's Plumbing **OR** John's Plumbing O/B John Smith.)
4. The Corporations Branch, Ministry of Justice and Attorney General, requires that all trading / business names be registered in Saskatchewan. Forms can be picked up at:

5. The **original bond** must be signed by the principal of the company, or at least one individual of an incorporated company, and submitted with the application and fees when applying for a contractor's licence.
